

## GENERAL

1. Instructions and information on how to enter form part of these Conditions of Entry. Participation in this Promotion (including by a companion) constitutes acceptance of these Conditions of Entry. Any capitalised terms used in these Conditions of Entry have the meaning given in the Definitions, unless stated otherwise. The resolution of any discrepancy between these Conditions of Entry and/or the advertising of the Promotion will be undertaken by the Promoter in its absolute discretion. All decisions and actions of the Promoter relating to the Promotion or redemption of the Prize are exercised at the Promoter's absolute discretion and are final. No discussions or correspondence with Entrants or any other person will be entered into by the Promoter.
2. **Definitions:**
  - 2.1. "Eligible Purchase" means the purchase of any Dahua camera product(s) within the Promotion Period from a participating Seadan or Sprint branch location.

## PRIZE

  - 7.1. There will be one (1) Prize Winner per participating branch.

## Entry Into Competition

- 8 **Entry Restrictions:** Eligibility to enter the Promotion is subject to:
  - 8.1. The Entrant being a current business customer with a Seadan or Sprint account in good standing;
  - 8.2. The Entrant placing an Eligible Purchase during the Promotional Period;
  - 8.3. The Entrant being located in any Australian state or territory.
  - 8.4. The Promotion is not available to resellers. Entries from resellers will be deemed invalid.

**Ineligibility:** Should an Entrant be deemed by the Promoter to be ineligible, the Entrant may not participate further in the Promotion. All decisions are at the discretion of the Promoter and no correspondence will be entered into in this regard.     - 14.2. Draws will be held at each branch (9) in total.
